The Public Health Association of Australia Inc (PHAA) is a non party-political organisation representing more than 40 public health related disciplines.

The Association makes a major contribution to public health as an advocate for public health issues primarily through submissions and by representation on boards, committees and consultative bodies. It acts as a forum for public health advancement and organises conferences and seminars to enhance the skills of public health practitioners.

PHAA has Branches in all States and Territories, has overseas members, and is affiliated with PHA New Zealand, the Australasian Epidemiological Association (AEA), Australian Health Promotion Association (AHPA) and the Australasian Faculty of Public Health Medicine (AFPHM).

PHAA has links with public health associations world-wide and is an active member of the World Federation of Public Health Associations.
